DISSERTATION

“Units of Agency in Ethics.” Committee: Jonathan Quong (chair), Stephen Finlay, Gregory Keating, Mark Schroeder, Ralph Wedgwood

My dissertation rethinks which units of agency should be of relevance to ethics. I argue that obligations and normative reasons for action can be possessed not only by individual persons, but also by larger units, namely groups, and by smaller units, namely the temporal parts of persons. I also defend views about how obligations and reasons for action possessed at different units of agency interact: for example, about when I have reason to do my part in what the group ought to do, and about how there could be irresolvable conflicts between individual and collective obligations.
